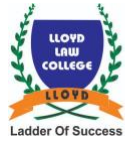

Regular classes & Attendance :: 80% physical class attendance in all cases ::

- **80% physical class attendance in regular classes is the minimum criteria for appearing in the University Examination failing which the College will not approve the Odd Semester examination form of the students to the university.**
